Restructuring of the didactic organization of the Degree Programme in Medicine and Surgery, and of the Degree Programme in Dentistry and Dental Prosthetics of the Faculty of Medicine

THE DEAN.

- Acknowledging the need to establish a more efficient structure for the didactic framework of the Degree Programme in Medicine and Surgery, of this Faculty;
- Considering the didactic organization of the Degree Programme in Medicine and Surgery at the University of Rome "Tor Vergata";
- Considering the regulation of the Degree Programme in Dentistry and Dental Prosthetics, at the University of Rome "Tor Vergata";
- Considering the decisions Prot.no. 19/18 dated 12/03/2018 and 15/19 dated 13/02/2019 of the Dean;
- Acknowledging that the didactic regulations of the Degree Programme in Medicine and Surgery and the Degree Programme in Dentistry and Dental Prosthetics at the Catholic University "Our Lady of Good Counsel" provide for a training course structured over six years, divided into 12 semesters;
- Noting that the total number of disciplines in the educational offer is 37 for the Degree Programme in Medicine and Surgery, totalling 360 ECTS credits in single subjects and integrated courses, and 41 for the Degree Programme in Dentistry and Dental Prosthetics, also totalling 360 ECTS credits.

hereby decrees,

Attendance at lectures is mandatory and must cover at least 67% of the lectures held for the Degree Programme in Medicine and Surgery and at least 60 % of the lectures for the Degree Programme in Dentistry and Dental Prosthetics.

Attendance will be verified by the lecturers and validated by the didactic secretariat.

Students who do not meet the minimum attendance requirement will not be permitted to sit exams.

Students may request partial exemption from attendance for serious and documented family or health issues; in case of illness, the relevant documentation must be issued by an accredited public health facility. The request for exemption and the documentation must be submitted promptly to the Dean's office of the Faculty of Medicine for the evaluation of the justification's validity.

Exams are conducted during the regular exam sessions, thus, in the summer, autumn and winter sessions, with each session having two ordinary calls.

An extraordinary call may be requested and conducted at a period during the academic year that does not significantly conflict with the regular schedule and attendance of classes.

For better organization, it would be advisable, that requests for extraordinary exams be submitted by student representatives.

Extraordinary exam calls, other than those institutionally provided for all regular students, are reserved exclusively for students of the Faculty of Medicine who are considered out of course and repeating students, provided they are compliant with the attendance requirement for the exams which they wish to take.

Extraordinary sessions shall be organized by the Dean's office in collaboration with the Didactic Coordinators, following the requests of the students involved; these requests will be assessed by taking into account the availability of the lecturers and the needs of the Degree Programme.

In order to be able to adequately organize the proper conduct of the exams with the involvement of the respective lecturers, students must register at least 7 days prior to the scheduled exam date, for organizational and travel arrangements purposes. The aforementioned deadline also applies to any cancellation of previously registered students.

In the event of a student's absence from the exam, or if the student expresses his/her wish to withdraw from the exam before taking it, or even after having passively attended the exam; it will be considered an absence from the exam.

Students who find themselves in the aforementioned situation will not be allowed to enrol for the same exam in the next following session.

Starting from the winter exam session, the prerequisites established by the didactic regulation must be strictly observed, as outlined in the table revised on 23/11/2022.

The provisions contained in this restructuring of the regulation apply equally to all students enrolled in the Medicine and Surgery Degree Programme.

Enrolment in subsequent courses must adhere to the obligation of passing a sufficient number of exams as outlined in the tables.

Regarding the didactic load between the third and the fourth year of the Degree Programme in Medicine and Surgery, this Regulation was initially applied to students enrolled in the second year for the academic year 2019/2020 and subsequently to all students in the first three years.
